Sr. Dir of Information Services Jason Rude spoke to the complaint advising the Board that the VPD has implemented a policy to waive all police fees in relation to the name change process for Residential School Survivors.

Committee Chair Mr. Allan Black recommended the VPD and Board write to the RCMP to remove this fee for specific individuals (Residential School Survivors) across Canada, and write to the Province requesting a review of the legislation in the *Name Act* pertaining to this matter. The Executive Director Ms. Stephanie Johanssen will work with Sr. Dir Rude on this correspondence and report back to the Board.

Inspector Alison Laurin spoke to this complaint which questioned the VPD's priorities in conducting seizure of cannabis from a group who was selling illicit cannabis from a recreational vehicle parked in the City of Vancouver. Insp. Laurin stated VPD officers were acting on their duty to enforce these laws and their actions were consistent with the findings of the B.C. Supreme Court and stated position of the CoV licensing department. Insp. Laurin noted no shortcomings were identified in the VPD's level of service or their policies.

Mr. Manojlovic spoke to this complaint noting the complaint objected to waiver language that is part of the police information check form that is consistent across the Province. With respect to the concerns of the complainant, the VPD has asked Police Services to reconvene the working group that oversees the information check system. The VPD is going to hold this issue until hearing back from Police Services to see if they determine it appropriate that the waiver language be modified. This process has begun, and the VPD is waiting to hear back.

The Board would like clarification with respect to the review, and if it isn't going to be taken in the foreseeable future, the VPD should review it again and report back to the Board.

Staff Sergeant Jason High spoke to this complaint regarding public safety and street disorder, particularly in the Downtown and Downtown Eastside (DTES). The complaint is concerned

regarding the VPD not doing enough to enforce the laws regarding open drug use, the sale of stolen goods, and camping on sidewalks and in parks. S/Sgt High stated after meeting with the complainant, the information provided was well received and the complainant recognized that many of the social issues expressed in the complaint are beyond the mandate of the VPD.
